The emergency assistance loan will support the government's KALAHI-CIDSS National Community-Driven Development Project. It will help build the capacity of communities to identify, prioritize, budget, and implement needed projects.

The project will support the implementation of the government's KALAHI CIDSS- National Community-Driven Development Project (KC-NCDDP) to restore basic social services and rebuild communities affected by Typhoon Yolanda (international name: Haiyan). The impact will be improved resiliency of poor communities to natural hazards. The outcome will be improved access to services and infrastructure for communities in affected provinces and their participation in more inclusive local disaster risk reduction and management planning, budgeting, and implementation.
