It will strengthen the capacity of coastal communities and institutions to manage coral reef resources and associated ecosystems. It will also support sustainable marine-based livelihoods.

The project will enable coastal communities, and the institutions that support them, to manage coral reef resources, and associated ecosystems and biodiversity in a sustainable manner for increasing the economic and social welfare of coastal communities. COREMAP-CTI will support the government's sector development plan and national targets for establishing effective Marine Protected Areas.
