## **Project Description**

This project upgrades power generation and distribution systems, including the construction of a 120-megawatt hydropower plant. It finances new energy efficient power generation equipment at existing plants; new distribution lines and substations; and financial management training and other support for staff of state power companies, Assam Power Generation Corporation and Assam Power Distribution Company. In addition, the program supports the construction of the Lower Kopili run-of-the-river hydropower plant in central Assam.
