### **Project Description**

According to ADB website, the Government of Republic of Union of Myanmar requested ADB for support for the improvement of rural infrastructure, including small and medium-scale irrigation systems, rural roads, and broader development of the rural sector during the preparation of the Country Business Operations Plan for 2014-2016 and the Initial Sector Assessment, Strategy, and Roadmap in agriculture, natural resources and environment sector of Myanmar (April 2013). A project preparatory assistance (PPTA) will help ensure compliance with ADB's requirements and incorporation of international best practices in the project design.

The PPTA will prepare an investment project for irrigated agriculture, including gathering of information and other baseline data, survey and feasibility study of the subprojects, and address the required due diligence:
