The Project Preparatory Technical Assistance will be divided into two parts: (i) Part A- Review of rural employment and rural enterprise projects<sup>1</sup> and (ii) Part B-Overall design and due diligence of the rural enterprise and rural employment project including development of inclusive business investments through partnership with the private sector and identification of policy issues.
