It also provides for Peshawar BRT Company, and increases capacity of Peshawar Urban Mobility Authority. Also, this project facilitates a bus industry transition, a scrapping and compensation program for non-participating transportation operators, furthers public-private partnerships, develops capacity of the traffic police, and implements a transit-oriented urban development strategy.
