### Project Description

The projects will be conducted in countries as Bangladesh, India, Indonesia, Myanmar, Pakistan, Philippines and Viet Nam which relate to risks of the most vulnerable populations to the current and future climate change. Those countries are eligible for Urban Climate Change Resilience Trust Fund (UCCRTF) and in consultation with the Operations Departments (OD).

Participants of the ADB Resilience Academy also were invited in consultation with the OD and came from cities that are already receiving support from UCCRTF for other urban planning and infrastructure investment activities. The multidisciplinary and iterative project design process employed at the ADB Resilience Academy reaffirmed the need for the three outputs of inclusive resilience planning, community-identified small-scale projects and driving towards an integration of community-level planning with city-wide planning.
