#### **Project Description**

According to Bank documents, the aim of this project is to strengthen the corporate governance and financial management of Georgia's electricity transmission company, Georgia State Electrosystem (GSE), and improve electricity market competition by supporting an independent market operator.

Reforms under this program include establishing an independent energy sector regulator, privatizing power generation and distribution assets, and introducing long-term concessions and guaranteed power purchase agreements for private investments in hydropower projects.
