Project Description

The TA seeks to improve development impact of ADB assistance to Mongolia to be demonstrated through improved country portfolio performance and higher client satisfaction.

The TA will support the government to (i) enhance its capacity to upgrade the regulatory framework for procurement inspections and audits through training and workshops; (ii) build government staff capacity to handle the procurement transactions of ODA-funded projects; and (iii) provide advisory support for the introduction of advance procurement and consultant recruitment actions in the national legal framework to reduce project start-up delays, and to speed up project implementation.
