## **Project Description**

On December 12 2016, the President approved a loan of up to \$20,000,000 to Khushhali Bank Limited (KBL) for Expanding Access to Credit for Agriculture and Micro, Small, and Medium-Sized Enterprise (MSME) Borrowers in Pakistan. 25% of ADB's funding will be targeted to female borrowers. The TA will help KBL increase its capacity to provide loans to MSMEs and farmers in order to realize their investment needs. The ADB TA contribution is only a small part of KBL's overall investment and KBL will be contributing two dollars from its own resources for every dollar of ADB funds spent.
