Zorlu Enerji is a global group of companies providing services in different areas of the energy sector. Zorlu Enerji Group offers an integrated service mix with the activities of different sectors of the energy sector, mainly electricity and steam production and sales carried out by Zorlu Energy, the only public company. Zorlu Enerji has a total installed power of 991 MW, of which 525 MW is in Turkey.

Zorlu Enerji has a 100 percent share of Zorlu Energy Pakistan that is 56.6 MW Wind Power Plant located in the Jhimpir Sindh. The Wind power plant, in Jhimpir started commercial activity in 2013. The facility, which is Pakistan's first wind power plant, produces approximately 159 million kWh of electricity per year.
