The knowledge and support technical assistance (TA) will support the National Health and Family Planning Commission (NHFPC) to assess the well-being and the social integration of migrants through:

- (i) analyzing the current situation of migrants and their families,
- (ii) examining international best practice,
- (iii) developing an evaluation index to measure social and physical integration, and
- (iv) providing evidence-based policy recommendations to improve the physical and psychosocial integration of migrant populations in urban areas.
