### Project Description

This project provides financing for the construction of agro-logistics centers in the provinces of Andijan and Samarkand, initially for the purposes of horticulture. According to Bank documents, these centers will provide all necessary facilities and services for agriculture, including storage, auction, food safety certification, customs clearance, quarantine, transport, shipping, trade finance and commercial banking.

The construction of these centers is planned to take place in two phases:

- The first will construct post-harvest buildings, cold storage, two wholesale markets for small farmers and customs, added value activities building, and administrative buildings.
- The second will construct wholesale markets for medium and large wholesalers, brokers and exporters, meat and dairy products pavilion, and upgrades for post-harvest buildings and train terminals.

The project is expected to be implemented between 2018 and 2023 and requires land acquisition.
