The loan will support Olam' \$223 million capex and expansion plan over the 2017-2019 period invest in Olam' midstream processing assets and permanent working capital for smallholder farmer supply in Timor-Leste, Papua New Guinea (PNG), Viet Nam, and Indonesia. The project will promote inclusive and sustainable agricultural value chains with higher local value addition in Southeast Asia and the Pacific.
