Project Description

Phase 1 of the project will construct, operate and maintain a 72 MW wind power plant in Jenepono (South Sulawesi). The Government of Indonesia has set ambitious targets to increase the share of energy supplied from renewable energy from 12% in 2013 to 23% in 2025.

Therefore, the Ministry of Energy and Mineral plans to increase the capacity of grid power generation through new and renewable energy to 45 GW by 2025 and wind energy shall contribute 1.8 GW thereof. The Project contributes to the acceleration and expansion of private sector investments in clean energy infrastructure in Indonesia.
