## **Project Description**

- Modernizing the coordinating dispatch center (CDC) Energiya, which coordinates power flow between the national electricity grids of the Central Asian Power System (CAPS), to enhance its technical capacity;
- Identifying the technical obstacles to power trade for CAPS, and proposing and coordinating solutions to overcome them for each country; and
- Supporting the expansion of CAPS membership and seeking new markets.
