### **Project Description**

According to the bank document, the transaction technical assistance (TA) facility is a subproject under the TA cluster for the Sustainable Infrastructure Assistance Program Phase II (SIAP2) to support project preparation, project implementation, and capacity building and policy advice to a series of ongoing and ensuing projects on water management and water security in the Republic of Indonesia during 2020 2023.

The TA facility will (i) build on partnerships to bring innovations including land and water management earth observations services; web-based asset management information systems and use of Light Detection and Ranging to improve operation and maintenance of water resources assets, and nature-based solutions;
