Project Description

The knowledge and support technical assistance (TA) to the Government of Kazakhstan through the Kazakhstan Housing Company (KHC) Joint Stock Company will help support the development of green housing finance. It will raise the understanding and provide policy advice on the selection of green technologies appropriate for the housing sector, build capacity on assessing their financial feasibility in housing project design, and transfer knowledge on how to design green housing in an urban planned unit development (PUD). Capacity building efforts will support KHC to deliver its mandate, to integrate green technologies and help establish more sustainable green construction and green mortgage finance mechanisms. The TA will support the country in addressing climate mitigation. Based on the concepts to be identified, the TA presents itself as a step in a larger strategy seeking to use the value of greenhouse gas (GHG) emission reductions to support other sectors of the economy to use green technologies.
