The road section is also part of the key corridors under the Central Asia Regional Economic Cooperation (CAREC) Program. This is the second attempt to complete this road section and will be using the fragile and conflict-affected situation (FCAS) approach by providing opportunities for greater participation of national contractors and consultants, facilitating community engagement through community development programs, and flexible security provision to the contractors."
