The TA will produce purchasing power parities (PPPs) and related results for the 2024 ICP cycle and conduct related statistical capacity building activities in the participating economies. The ICP is a globally coordinated statistical initiative under the auspices of the United Nations Statistical Commission (UNSC), that will produce PPPs, PPP-based internationally comparable volume measures of gross domestic product (GDP) and its components.
