Through a strategic, coordinated, and well-sequenced set of policy actions, the program will facilitate both immediate and critical medium-term reforms. Four reform areas identified under the program will focus on:

- strengthening planning and preparedness of the health sector, and ensuring the availability of critical medicines and emergency supplies;
- improving national pharmaceutical regulation, and increasing hospital autonomy and good governance;
- enhancing procurement in the health sector to increase efficiency, and establishing a single purchaser for health services; and
