Project Description

According to the bank's website, "Tropical cyclone (TC) Harold, a category 4 cyclone, struck Fiji on 8 and 9 April 2020. With average hurricane force winds over 170 km/h and gusts up to 240 km/h, the cyclone caused widespread destruction across the Central, Eastern, and Western divisions in Fiji. Many small and remote islands lay in the direct path of TC Harold. It is estimated that more than 182,500 people in Fiji (or around 20% of the population) were directly affected. Destructive winds, storm surges and flooding from TC Harold destroyed villages, homes and government buildings, and severely damaged agriculture and infrastructure, including for water supply, waste and sanitation, electricity, and communications. An estimated 90% of crops have been destroyed in the most affected areas, leaving families with no alternative food source. Outbreaks of typhoid, leptospirosis, and dengue fever have been identified by the Ministry of Health as a major concern."
