### Project Description

The ADB states that the objective of the project is to expand the market for energy efficiency technologies and services in Cambodia.

The Sector Development Program encompasses three output areas, and technical training and awareness raising programs on energy efficiency for various government agencies and the utility will be supported as a cross-cutting measure. The modality was chosen to allow support for enabling policies and programs, alongside support for key demonstration-scale investment projects, in a synchronized manner.

The project investments will demonstrate new technologies in energy efficiency and storage including (i) the country's first grid-connected energy storage system, which will enable additional renewable sources to enter the grid and improve grid stability for consumers; and (ii) comprehensive city-level efficient street-lighting systems in Kampot and Kep provinces, which will demonstrate cost savings and benefits for tourism and public safety. The project component will also improve capacities for new technology scale-up to kick-start new markets.
