According to the bank's website, "the proceeds of the Asian Development Bank (ADB) loan, and loans to be provided by Deutsche Investitions- und Entwicklungsgesellschaft mbH (DEG) and the OPEC Fund for International Development, will be used to finance or refinance the construction of a manufacturing facility, purchase of equipment, and other capital expenditure in Viet Nam for the production of baby diapers, wet wipes, and women's hygiene pads. The project will increase consumer choices and improve the affordability of baby diapers, wet wipes, and women's hygiene pads in Viet Nam, Thailand, and Malaysia."

Private Actors Description

As stated by the ADB, established in 2019, Hayat Kimya is a wholly owned subsidiary of Hayat Kimya Sanayi. The greenfield factory in Viet Nam, initially for baby diapers and baby wipes but to be expanded to women's hygiene pads, is the group's first manufacturing investment in Asia and will play a major role in rolling out its products to Viet Nam, Thailand, and Malaysia. The production of diapers and sanitary wipes started in the third quarter of 2021. Hayat Kimya Sanayi was incorporated in Istanbul, Turkiye more than 50 years ago and is mainly engaged in the production of detergents, and hygiene and tissue products. It achieved \$2.0 billion in revenue in 2021 and owns 15 brands across multiple consumer product categories, including baby diapers, feminine hygiene pads, adult diapers, masks, detergents, wet wipes, toilet papers, and tissues. As of 31 December 2020, the group had 9,000 employees and 21 manufacturing facilities. In 2018, it ranked 41st among Türkiye's largest exporters and 47th among Turkiye's top 500 industrial entities (footnote 2). It is the world's fifth largest branded baby diaper manufacturer and the largest tissue manufacturer in the Balkans, Eastern Europe, and Middle East.
