## **Project Description**

According to ADB, the transaction technical assistance (TA) through this project will help the government develop the capacity of the executing agency, the National Capital Region Transport Corporation (NCRTC), in: (i) improving mobility of elderly, women, children, and differently abled through various mobility solutions within and beyond the catchment area of the Delhi-SNB RRTS corridor; (ii) augmenting urban finance and strengthening domestic resource mobilization for sustainable RRTS operations; (iii) undertaking climate change adaptation and mitigation measures; and (iv) developing urban growth poles along the Delhi-SNB RRTS corridor to spur economic development in the NCR, particularly in the state of Haryana.
