Project Description

According to the Bank's website, thehe proposed program will improve the resilience of the Cook Islands, the Federated States of Micronesia (FSM), the Republic of the Marshall Islands (RMI), and Tuvalu to disasters triggered by natural hazards and health emergencies. It supports reforms to strengthen climate and disaster risk management (DRM), including health emergency preparedness.

The program is the fifth phase of the Pacific Disaster Resilience Program (PDRP), initially approved in December 2017. It comprises loans and grants under the contingent disaster financing (CDF) option under the policy-based lending (PBL) modality, with a post-program partnership framework (P3F) to ensure the continuation of reforms between PDRP phases.
