According to the Bank's website, the proposed Water Sector Reform Program aims to implement a series of water sector reforms in Sri Lanka by addressing vulnerabilities for improved sector performance and environmental sustainability. The policy support will contribute to resilient and sustainable water and sanitation services delivery in accordance with Strategy 2030 of the Asian Development Bank (ADB).

## Investment Description

- Asian Development Bank (ADB)

ADB will provide a concessional loan of \$100 million to be disbursed in fiscal year 2024 for subprogram 1 to the Government of Sri Lanka.

The proposed attached TA will provide capacity and advisory support in formulating, deploying, implementing, and monitoring reform initiatives, mainly under subprogram 2 to the MWS, NWSDB, and other stakeholders. The TA is estimated to cost \$500,000, which will be financed on a grant basis from ADB's Technical Assistance Special Fund (TASF-other sources).
