### **Project Description**

According to the Bank's website, the Improving Economic Management Program will help the Government of Tonga implement reforms to mitigate fragilities intensified by the coronavirus disease (COVID-19) pandemic and the 2022 volcanic eruption at Hunga Tonga-Hunga Ha'apai (HTHH) and associated tsunami waves. The program comprises two subprograms that will (i) strengthen public sector management and sustainability, and (ii) boost economic and social resilience in Tonga.
