#### **Project Description**

As stated by the ADB, the knowledge and support TA will strengthen the development and delivery of our country partnership strategy in Indonesia. This will be done through strengthening the institutional capacity and practices of executing and implementing agencies in preparing and implementing ADB financed projects. It will also support inclusive and evidence-based dialogue on development objectives. The support is expected to result in a new Country Partnership Strategy which reflects the priorities of key stakeholders, and an improved portfolio quality in Indonesia, with reduced set-backs that lead to project contract award and disbursement delays.

Indonesia is finalizing its new National Long-Term Development Plan (RPJPN) 2025-2045. It is anticipated to be finalized prior to the start of political campaigning for the presidential and legislative elections due to take place in early 2024. A new National Medium-Term Development Strategy (RPJMN) is also being developed with the expectation that it will be finalized in 2025 following the inauguration of the new government in late 2024. Indonesia emerged strongly from the pandemic and is focusing on critical reforms and investments required to eliminate poverty, reach net zero emissions and build the human capital to obtain their goal of becoming a high income country by 2045.
