Project Description

According to the Bank's website, the proposed technical assistance (TA) will provide capacity-building support to the government in improving project implementation and enhancing project readiness of future pipelines in line with the Bangladesh Country Partnership Strategy (CPS) 2021-2025. The proposed TA will also provide knowledge support through upstreaming and just-in-time knowledge to enhance pipeline development and policy dialogue. At the same time, the TA will facilitate the effective sharing of One ADB knowledge. TA activities will be coordinated and implemented by the Capacity Development Resource Center in Bangladesh Resident Mission (BRM-CDRC).
