### **Project Description**

As stated by the ADB, the technical assistance (TA) will strengthen the capacity of the Government of Georgia to realize its vision of becoming a green an inclusive regional gateway. It will also help the Asian Development Bank (ADB) pivot its assistance program toward more climate action and gender mainstreaming. The TA will provide a multisector and integrated approach to capacity development, policy advice, project identification, and support to project preparation and implementation.
