Project Description

According to the Bank's website, the TA will support the Ministry of Housing and Urban & Rural Development (MHURD) to (i) develop a standard and database related to urban construction life cycle carbon dioxide (CO₂) emissions on buildings; (ii) prepare technological pathways of low-carbon urban transition towards carbon neutrality; and (iii) develop policy incentives promoting low-carbon urban transition. Based on the research and pilot implementation, the TA will provide policy advice, enhance capacity of XX (with at least 35% women), and disseminate knowledge.
