

### **Project Description**

According to the bank website, the project responds to the need for reforms to support inclusive growth, ensure a modernized administration, and promote the financial autonomy and economic viability of local governments. The overall cost of the PAMREC pilot phase is estimated at CFAF 3,003,901,293, including CFAF 2,336,688, from the Bank, i.e. about UA 3,000,000. Implementation will take 30 months.

PAMREC's objective is to improve the financial situation of Cote d'Ivoire's municipalities and local governance. In the short and medium-term, the project will help to (i) digitize the local tax collection and registration system of the municipalities; (ii) modernize the municipalities' financial and accounting services; (iii) make available staff with enhanced capacity; (iv) generate local employment and job opportunities, especially for women who are underrepresented in the administration of municipalities; (v) provide objective data to support local government public finance reforms; and (vi) increase the financial capacity of the municipalities to support development initiatives directly benefiting the local population with broad-based and operational training opportunities.
