## Project Description

This project sets out to conduct studies for the preparation of an investment program for the construction of 300 small-scale drinking water supply networks in the rural areas of Cameroon. Its goal is to enhance the efficiency of drinking water and sanitation sub-sector investments through research and capacity building activities, and provide information crucial to the management of Cameroon's water resources. Furthermore, it will contribute towards mobilizing the funds needed to finance the construction of the mini-networks for which the studies are conducted. The lead time of the project study is 30 months.
