According to bank documents, the overall goal of ADRiFi in Mauritania is to enhance the resilience and response to climate shocks in the country by improving the management of climate disaster risks. The Programme's specific objectives are: (i) To strengthen the capacity of Mauritania to evaluate climate-related risks and costs, and elaborate subsequent adaptation measures at both national and sub-national levels; (ii) To promote initial financing for disaster risk transfer solutions.
