#### **Project Description**

According to the Bank's website, the project consists of (i) enabling environment for agro-industrial development and MSMEs strengthened; (ii) the regulatory framework and processes for investment facilitation streamlined; (iii) Gender and climate change mainstreamed in economic development; (iv) internal controls and anti-corruption mechanisms strengthened; (iv) efficiency, transparency and equity in public procurement increased; (v) transparency and accountability for sustainable debt management strengthened. Overall timeframe: 2023-2024, two-year programmatic operation.

The key outcomes of the Program are (i) Business enabling environment to support economic recovery and green growth improved; and (ii) Efficiency, accountability and transparency of public expenditure strengthened.
