Project Description

According to the bank website, the project involves the development and/or rehabilitation of 786.20 kilometers of roads. Considering the huge amount of financing to be mobilized, the Government proposed that the program be financed in several phases. Phase 1 will concern 482.94 kilometers of roads covering the Kidira-Bakel section (65 kilometers), the Boucle du Riz section (172.44 kilometers), the Louga-Keur Momar Sarr-Richard Toll section (116.27 kilometers), the Orofondé-Matam section in Dandé Mayo Nord (104.23 kilometers), and a 25-kilometre stretch of National HighwayNo. 2-RN2 (Thiès-Kébémer). The expected outcomes are: (i) a boostin rice and mining production through an increasein vehicle traffic; (ii) reduction in general transport costs [vehicle operating costs (VOC) + travel time]; (iii) development of climate-resilient road infrastructure; and (iv) improvement of access to and conditions for implementing socio-economic activities in the programme impact area, especially for the most vulnerable groups (women and young people). socio-economic and marketing infrastructure, and support women's and youth groups, particularly for the processing of agricultural produce. The program will help to construct a weighing station, improve road safety by ensuring the rapid treatment of victims of road traffic accidents, enhance youth employability by operating site-schools in the construction and agricultural sectors, and build the capacity of the program executing agency.
