### Project Description

According to the Bank's website, the project's overall development objective is to build peace, inclusiveness and resilience in the South Sudanese communities affected by the current conflict in Sudan. Specifically, the project aims at (a) supporting the inclusive and peaceful integration of refugees and returnees into the communities, (b) social cohesion strengthening amongst refugees and host communities and (c) enhancing the socio-economic wellbeing of the affected communities.

The project will be implemented in Maban (Upper Nile), Jamjang (Ruweng Administrative Area), Aweil (Northern Bahr El Ghazal) and the City of Juba targeting the host communities, refugees and South Sudanese normally resident in Sudan but escaping the conflict (returnees). The selection of targeted Counties/project sites was guided by the inflow size of returnees and refugees, government's guidance and the need for geographical balance between the three greater geographical areas of the country (i.e.; Upper Nile, Bahr el Ghazal and Equatoria). To a great extent, the project will prioritise strengthening services and opportunities within the host communities which will also benefit and be available for use by the refugees and returnees.

### Investment Description

- African Development Bank (AFDB)

The project will be financed by a grant from TSF Pillar I Crisis Response Envelope of UA 15 million (USD 19.8 million) net of taxes and duties and a grant contribution of UA 1.84 million (USD 2.43 million) from UNHCR. The overall project cost is estimated at UA 16.84 million (USD 22.23 million).
