According to the bank website, the project concerns the development of the Pointe-Noire-Brazzaville-Bangui-Ndjamena multimodal transport corridor. The corridor thus determined is part of the Central African Consensual Transport Master Plan (PDCT-AC), adopted under the aegis of the Economic Community of Central African States (ECCAS) which aims to: (i) connect the economic and/or political capitals of the Community's Member States to each other by asphalt roads, including transit corridors; (ii) implement the NEPAD road projects; and (iii) rehabilitate and commission existing airports, ports, inland waterways and railways.
