According to AfDB website, the ADF-15 Performance Based Allocation (PBA) grant of UA 3 million, and Regional Operations Envelope (RO) grant of UA 27 Million to the Republic of Djibouti; and an RO grant of UA 10.98 Million and a TSF-Pillar I grant of UA 7.32 Million to the Federal Republic of Somalia, is to finance the Crisis Response Support Programme for National and Regional Mitigation of COVID-19 Impact (Djibouti and Somalia).
