Project Description

According to AfDB:

"The project is designed in line with countries National Post Ebola Recovery Plans and guided by the findings of the recently undertaken Ebola Recovery Assessment (ERA) mission to the sub-region in January 2015. The ERA was in response to a call by the UN Secretary-General and the Governments of Liberia, Guinea and Sierra Leone and conducted by a multi-partner team led by the UNDP, AFDB, WB and EU to contribute to laying the foundation for the short, medium and long term recovery while the emergency response continues to contain the epidemic. In effect, the ERA mission served as an identification mission for this project. All three governments have prioritized health care and nutrition, WASH, education, agriculture and social protection for recovery. The project can be designed in a number phases and the design shall be as flexible as possible and go beyond the three affected countries by considering also all the neighboring countries or all ECOWAS countries."

The project has the following components:


Component 1: Restoring and strengthening capacity of public health systems and basic social services
