The main components of the entire project include:

- 1. Civil Works for;
  - i. the Rehabilitation of the Chinsali Nakonde road section (210km) in Zambia;
  - ii. Rehabilitation of 50km of feeder roads and
  - iii. Complementary Initiatives/ Social Infrastructure
- 2. Consulting Services for
  - i. Design Review and Supervision of the Works;
  - ii. Sensitisation of project area inhabitants on HIV/AIDS, STIs, Communicable Diseases and Environmental Protection;
  - iii. project Audits Financial and Technical;
  - iv. Monitoring and Evaluation of Project Impacts;
  - v. Road Safety and
  - vi. Sector Studies Feasibility and Detailed Engineering Design of Feira crossing in Luangwa (Zambezi River).
- 3. Trade Facilitation
- 4. Resettlement and Compensation
- 5. Institutional Support.

The civil works for the Chinsali - Nakonde road section will be implemented in two lots, namely, Lot 1: Isoka - Nakonde (110km) and Lot 2: Chinsali - Isoka (100km). The civil works are to be implemented in parallel, estimated construction time of 30 months (2.5 years) for each.
