### Project Description

According to AIIB website, the Project will be built on the previous experience in preparation and implementation of the Dam Safety Project (DSP:1994-2003) and the Dam Operational Improvement and Safety Project (DOISP: 2009-2016). The DOISP was envisaged as the first stage of a longer-term programmatic approach by Government to develop a portfolio management approach across its dam and reservoir sector. The overall aims of the program were:

1. To increase the safety and the functionality of the 63 short-listed prioritized large dams/reservoirs,
2. Develop and mainstream the regulatory and administrative arrangements for dam and reservoir management and safety that are more sustainable from a technical, environmental and financial perspective.

The Project will consist of the following components:

1. Institutional Capacity for Dam Safety;
2. Dam Rehabilitation and Safety;
3. Dam Operation and Safety Management.

### ACCOUNTABILITY MECHANISM OF AIIB

The AIIB has established the Accountability Mechanism for Project-Affected People (PPM). The PPM provides “an opportunity for an independent and impartial review of submissions from Project-affected people who believe they have been or are likely to be adversely affected by AIIB’s failure to implement the ESP in situations when their concerns cannot be addressed satisfactorily through Project level GRMs or AIIB Management processes.” Two or more project-affected people can file a complaint. Under the current AIIB policy, when the bank co-finances a project with another development bank, it may apply the other bank's standards.
