Project Description

The stated aim of this project is to improve road transport connectivity in previously unserved communities by providing allweather rural roads in 13 districts of the state of Andhra Pradesh.

According to AIIB documents, this project has two components:

Component 1: Construction of new connectivity consisting of:

- (i) Construction of about 3,000 km of bitumen paved roads in the locations with soft soil
- (ii) Construction of about 2,500 km of cement concrete paved roads, in the locations with hard soil
- (iii) Construction of about 60 bridges and hydraulic structures (culverts) to increase connectivity of the roads during the monsoon season.
