Project Description

The objective of this project is "to strengthen the public health emergency response infrastructure in Chongqing and Beijing through the provision of emergency supplies and the upgrading of public health infrastructure."

The Project will have two parts:

Part One: Strengthening of public health emergency response capacity in Chongqing:

Component 1.1: Providing emergency supplies and equipment to help contain the outbreak of COVID-19 in Chongqing.

Component 1.2: Systematic upgrading of the Centers for Disease Control and Prevention (CDCs) at all administrative levels and the treatment capacity of hospitals in dealing with epidemic emergencies.

Part 2: Strengthening of public health emergency response capacity in Beijing:

Component 2.1: Providing emergency supplies and equipment and supporting the upgrading of hospitals to help contain the outbreak of COVID-19 in Beijing.

Component 2.2: Capacity enhancement of the municipal-level CDC and the treatment capacity of municipal hospitals in dealing with epidemic emergencies.

ACCOUNTABILITY MECHANISM OF AIIB

The AIIB has established the Accountability Mechanism for Project-Affected People (PPM). The PPM provides “an opportunity for an independent and impartial review of submissions from Project-affected people who believe they have been or are likely to be adversely affected by AIIB’s failure to implement the ESP in situations when their concerns cannot be addressed satisfactorily through Project level GRMs or AIIB Management processes.” Two or more project-affected people can file a complaint. Under the current AIIB policy, when the bank co-finances a project with another development bank, it may apply the other bank's standards. You can refer to the Project Summary Information document to find out which standards apply.
