### Project Description

As stated by the AIIB, the Project involves the development, design, engineering, construction, operation, and maintenance of a 500 MWac Manah solar I photovoltaic power plant in the Ad Dakhiliyah region of the Sultanate of Oman.

The Project is being developed by EDF Renouvelables and Korea Western Power Company Ltd., through a special purpose vehicle, which has entered into a 20-year Power Purchase Agreement commencing from the scheduled commercial operations date with Oman Water and Power Procurement Company SAOC in March 2023. Post the PPA expiry, the Project Company will be eligible to sell the electricity under the spot market regime in Oman.

*As of November 27, 2024, the project disclosure does not appear on the AIIB's website anymore, indicating the project might have been dropped or canceled.*

## ACCOUNTABILITY MECHANISM OF AIIB

The AIIB has established the Accountability Mechanism for Project-Affected People (PPM). Two or more project-affected people can file a complaint. Under the current AIIB policy, when the bank co-finances a project with another development bank, it may apply the other bank's standards.
