The objective of the project, as stated by the AIIB, is to contribute to the initial phase of Antalya Airport expansion through the provision of a capex bridging loan.

The Project comprises three components:

Terminal Works: expansion of International Terminal 2, Domestic Terminal and related carparks;

Airside Works: additional apron space and taxiways, infrastructure works for new maintenance hangar area, cargo terminal; and

Other Works: gates, landscaping, on-site solar farm, and others.

The Project will increase the annual capacity of the Antalya Airport from 40 million passengers to 80 million passengers in three phases.
