Project Description

According to the AIIB, the project development objective is to support the development of low-carbon solutions in the energy and water sectors in Brazil.

AllB will invest USD 40 million in Vinci Climate Change A, LP (the "Fund" or "VICC") as a limited partner, with another USD 10 million in the co-investment sleeve. The Fund was launched by Vinci Infraestrutura Gestora de Recursos Ltda. ("Vinci") in 2023 (Vinci held the first closing of the strategy in 2022 through a Brazilian vehicle) with a fundraising target of USD 400 million to develop a portfolio of assets in renewables, water and sewage, and in green technologies located in Brazil.



ACCOUNTABILITY MECHANISM OF AIIB

The AIIB has established the Accountability Mechanism for Project-Affected People (PPM). The PPM provides "an opportunity for an independent and impartial review of submissions from Project-affected people who believe they have been or are likely to be adversely affected by AIIB's failure to implement the ESP in situations when their concerns cannot be addressed satisfactorily through Project level GRMs or AIIB Management processes." Two or more project-affected people can file a complaint. Under the current AIIB policy, when the bank co-finances a project with another development bank, it may apply the other bank's standards. You can refer to the Project Summary Information document to find out which standards apply.
