## Investment Description

- Caribbean Development Bank (CDB)

The information disclosed by the CDB is unclear. On project documents, it is stated that the CDB will provide a loan of USD 3.2 million and a grant of USD 0.09 million. The Government of Anguilla will contribute with USD 2.5 million. However, on the project disclosure page, the approved total amount is USD 6,108,000.
