According to the CDB, the project will set up a reliable and climate-resilient supply of potable water to residents and businesses in the north of Saint Lucia; and enhance management and operational capacity of the Water and Sewerage Company Inc. in the areas of gender inclusion, climate resilience planning, and financial management.

According to the Project Summary:

The expected outcomes of the project are: a reliable and climate resilient supply of potable water to residents and businesses in the north of St. Lucia; and (b) enhanced management and operational capacity in WASCO in the areas of gender inclusion, climate resilience planning, and financial management. The proposed project consists of the following components:

- (a) Project preparation studies;
- (b) Land acquisition;
- (c) Infrastructure works comprising:
- (i) Sediment removal and disposal;
- (ii) Repairs to spillway and the John Compton Dam access road;
- (iii) Development of supplementary water intakes; and
- (iv) Installation of dam monitoring instrumentation.
- (d) Capacity building of WASCO comprising:
- (i) Gender Capacity Building in the Water Sector;
- (ii) Climate Vulnerability Assessment and preparation of an adaptation plan;
- (iii) Capacity building in the Finance Department;
- (e) Tete Chemin Rainwater Harvesting Initiative;
- (f) Watershed Restoration Works;
- (g) Project management; and
- (h) Engineering services.
